Background:

With the outbreak of COVID-19 and Public Health's current guidance not to have large, in-person events, Sallal's Board of Trustees was faced with the dilemma of what should we do about Sallal's Annual Meeting that was scheduled for March 30th? We could either reschedule to a future date (but how far out do we need to go to avoid this outbreak and how does that affect the number of months the newly-elected Board Members would serve) or do we keep the original date of the meeting and use a group conferencing system. At the March 17th Board meeting we tried using Zoom's conferencing system. It seemed to work well, so we will also use it for the Annual Meeting (still on Monday, March 30th at 7:00 PM). Some of the reasons we selected this system:

- You do ***NOT*** need to have a computer to participate. There is an option to just call in with a phone.
- It works well and the different features are easy to understand. (Both from a participant perspective and from our staff's perspective.)
- This can be scaled up to include ***all*** of Sallal's members.
- The members will have multiple ways to ask questions:
 - o The best way would be to send your questions ***a few days before the meeting*** to admin@sallal.com This way we can see if there seem to be recurring questions that we could answer earlier in the evening and be respectful of everyone's time.
 - o There will also be a 'Question & Answer' box in the online environment.
 - o The online environment also enables the participants to electronically 'raise their hand' and we can unmute their microphone and they can just ask the question. (We will also temporarily unmute the folks that are calling in so they have an opportunity to talk.)
